Dear Mr. Gatewood and Mr. Lockwood:

On April 29, 2025, Disciplinary Panel A of the Maryland State Board of Physicians issued an **ORDER FOR SUMMARY SUSPENSION OF LICENSE TO PRACTICE MEDICINE**, pursuant to Md. Code Ann., State Gov't § 10-226(c)(2), against George Gatewood, III, P.A. Mr. Gatewood was given an opportunity for a post-deprivation hearing before Disciplinary Panel A to argue that the order for summary suspension should not be continued. The post-deprivation hearing was scheduled for May 14, 2025. On May 11, 2025, Mr. Gatewood requested a postponement of the hearing in order to find an attorney among other reasons. On May 12, 2025, the Board granted the postponement and rescheduled the post-deprivation hearing to be held on June 11, 2025. On May 19, 2025, Mr. Gatewood sent an email to the Board stating that he would waive his right to the post-deprivation hearing. Due to the waiver, no post-deprivation hearing will be held by Panel A and the order for summary suspension, imposed on April 29, 2025, is reaffirmed and continues in effect; and Mr. Gatewood may request an evidentiary hearing on the merits to appeal the order for summary suspension.

NOTICE OF RIGHT TO APPEAL

Under COMAR 10.32.02.08I, Mr. Gatewood has the right to request a full evidentiary hearing before an Administrative Law Judge on the order for summary suspension. This request will be granted if the Board receives a written request for a hearing within **TEN (10)** days of the date of this letter. The request for a hearing shall be sent to:
