Dear Dr. Wormuth and Counsel:

On March 26, 2025, Disciplinary Panel A of the Maryland State Board of Physicians issued an **ORDER FOR SUMMARY SUSPENSION OF LICENSE TO PRACTICE MEDICINE**, pursuant to Md. Code Ann., State Gov't § 10-226(c)(2), against Jennifer Wormuth, M.D. Dr. Wormuth was given an opportunity for a post-deprivation hearing before Disciplinary Panel A to argue that the order for summary suspension should not be continued. The post-deprivation hearing was scheduled for April 9, 2025. On April 7, 2025, Dr. Wormuth's attorney sent an email to the Board stating that Dr. Wormuth would waive her right to the post-deprivation hearing. Due to the waiver, Panel A did not hold the post-deprivation hearing; the order for summary suspension, imposed on March 26, 2025, is reaffirmed and continues in effect; and Dr. Wormuth may request an evidentiary hearing on the merits to appeal the order for summary suspension.

NOTICE OF RIGHT TO APPEAL

Under COMAR 10.32.02.08I, Dr. Wormuth has the right to request a full evidentiary hearing before an Administrative Law Judge on the order for summary suspension. This request will be granted if the Board receives a written request for a hearing within **TEN (10)** days of the date of this letter. The request for a hearing shall be sent to:
