Ms. Harris informed the Committee that the Board approved the ATAC's recommendations to remove the following Specialized Tasks from the List of AT Board-Approved Specialized Tasks at its meetings on November 20, 2024, and January 29, 2025:

- Graston Technique
- Interpreting a Neuro-Psych Concussion Test (Immediate Post-Concussion Assessment and Cognitive Testing – Impact)
- Ability to Use a Peak-Flow Meter to Monitor Breathing
- Administering Oxygen
- Emergency Administration of Nebulizer Treatment
- Manual Reduction of Glenohumeral Dislocations
- Manual Reduction of Interphalangeal Dislocations
- Manual Reduction of Patellofemoral Dislocations
- Casting Removal
- Manual Reduction of Joint Subluxations - Glenohumeral
- Manual Reduction of Joint Subluxations - Paraspinal Muscle

The Committee recommended removing the above tasks from the specialized tasks list because they are included in an athletic trainer's core training education and practice.
